# MEMBERSHIP INFORMATION



**STATEMENTS** - Statements are sent out month, and must be drafted in full by the 15th of each month by ACH or Credit Card. Delinquent fees are assessed on accounts not kept current. If an account becomes 60 days delinquent, it is automatically suspended. Payment in full is due to reinstate privileges. If the account is not paid, the member will be expelled and turned over to agents for collection.

**OWNERSHIP** - Membership in the Club does not include any ownership interest of any of the assets thereof or any ownership interest in any assets of the surrounding community (including any real property or common areas), nor does it entitle the Member to participate in the earnings of the Club or create any voting or management rights therein.

**FAMILY** - Each and every individual accepted as a Member of the Club recognizes that the privileges of membership in the Club are appurtenant only to the Member and their spouse. However, the family of the Member may be entitled to the use of the Club facilities available to the Member. Dependent children unmarried, under 21, or college students through age 25, who reside with Member and only after payment of such fees and charges, if any, established therefore by the Ownership.

**FITNESS CENTER** - The Fitness Center is for **MEMBERS ONLY**. Guests are never allowed.

*I, as a Member of Chateau Golf and Country Club, hereby agree to indemnify and hold the Club harmless from any liability it incurs as the result of my utilization of the Clubs fitness facilities, services and programs. I will follow all RULES and REGULATIONS that are posted in the Fitness Center.*

**RESTRICTIVE STARTING TIMES** - The Ownership may establish restrictive starting times for Golf on a gender or other similar basis. For example, ladies only starting times, men's only starting times or mixed couples starting times are permitted to be established in order to promote camaraderie among Members.

**RESIGNATION** - A Member may resign from the Club by giving thirty- (30) days advance written notice to the Club and by paying all dues and other charges that are due. (Initiation Fees are non-refundable)

**TERMINATION** - A Member maybe terminated by Ownership by written notice.

**NON-TRANSFERABLE or DIVIDABLE** - Membership may no be transferred to another party or family members. Applicant agrees that in the event of a corporate reorganization or personal divorce, this Membership is not dividable and this Membership shall be allocated by agreement of all claimants or on the absence of agreement, by court order. Such allocations are subject to the sole approval of the Clubs ownership. The successor to the Membership shall execute all necessary papers and pay all allocation fees required b y the Club.

# RULES & REGULATIONS



## MEMBERSHIP RULES AND REGULATIONS

Applicant hereby acknowledges that Applicant has received, has read, understands and agrees to the Membership Rules and Regulations for Chateau Golf & Country Club applicable to this membership, which are incorporated herein by reference. Applicant hereby agrees that Applicant's use of the Club and privileges under the membership are subject to the terms, conditions and restrictions set forth therein. Applicant agrees to conform to and abide by said Membership Rules and Regulations as each may be amended from time to time. The Club reserves the right, in its sole and absolute discretion, to terminate memberships in the Club, to discontinue operation of any or all of the Club facilities, to sell or otherwise dispose of the Club facilities in any manner and to make any other changes to the terms and conditions of membership or use of the Club facilities. Where applicable, references to the "Club" shall mean the management of the Club as appointed by the Owner. Applicant hereby acknowledges and agrees that the Applicant is acquiring the membership for the sole purpose of obtaining recreational use of the Club facilities, and not as an investment or for economic gain or profit.

## CORPORATE MEMBERSHIP (IF APPLICABLE)

Corporate Memberships are held by an Authorized Entity, who can specifically name one (1) Primary Designee and up to three (3) additional individual Designated Players to have the rights and privileges of the category of membership acquired by the Authorized Entity (singularly, a "Designee," collectively, "Designees"). All Designees must be owners or bona fide employees, directors, executives or officers of the Authorized Entity. The Authorized Entity is required to pay one hundred percent (100%) of the then current Membership Initiation Fee for Full Golf Membership for the Primary Designee. Designees may be changed by the Authorized Entity no more than once per year, and each new Designee is subject to approval in the same manner as other candidates for membership, payment of the then current re-designation fee and compliance with the then current re-designation policy. In addition, all Corporate Memberships shall be subject to the conditions and restrictions set forth in the Rules and Regulations of the Club. Membership Cards will be issued in the name of each approved Designee.
